AGREEMENT FOR COOPERATIVE PROGRAM  
BETWEEN AN ACADEMIC UNIT OF THE UNIVERSITY OF PITTSBURGH  
AND AN ACADEMIC UNIT OF UNIVERSITY OF FERRARA

This Agreement is made as for a Cooperative Program ("Agreement") and is entered into by and between the University of Pittsburgh - Of the Commonwealth System of Higher Education, (hereafter "University of Pittsburgh"), Pittsburgh, Pennsylvania, USA, and University of Ferrara , located in Ferrara, Italy, through its (hereafter referred to as "University of Ferrara") collectively referred to as the "Parties".

1. **Purpose:** The purpose of this Agreement is to enhance the international cooperation among the Parties.
2. **Term and Termination:** The term of this Agreement shall be for an initial five (5) year term, commencing on the date of its execution by the last to sign of University of Ferrara and University of Pittsburgh, optionally followed by five (5) year renewal terms provided both parties concur in writing. However, this Agreement may be terminated by either Party by providing written notice of termination from an authorized signatory no later than January 31<sup>st</sup> of the year in which the termination is to become effective. Following such notice, the termination shall be effective at the conclusion of the then current academic year. In addition, each party shall have the right to terminate this Agreement upon sixty (60) days' notice where the other party has breached any of its obligations under this Agreement and such breaching party fails to remedy such breach within the sixty (60) day notice period.
3. **Administration:**
  - 3.1 Within such fields as mutually acceptable for the Parties, the following forms of cooperation, amongst others, may be pursued hereunder:
    - Creation of a reciprocal exchange program of fellowship trainees in Cornea & External Disease and Vitreo-Retinal Surgery. Exchange rotations shall be from six (6) up to twelve (12) months.
    - Organization of conferences, lectures, symposia and/ or educational courses
    - Conduct of joint research activities
  - 3.1 **General coordinators:** Each Party shall designate a coordinator of this MOU to oversee and facilitate the implementation of any agreements arising out of it. The coordinators are:
